Whereas, DMRRR vide their OM No: DMRRR-Adm/58/2022 dated: 07.06.2022, advised to have a separate seniority list of the candidates so that their promotion prospects can be ensured: and

Whereas, vide this office Communication No. RRCM/ESTT/22-23/667 dated: 20-06-2022 the tentative Seniority list of Drivers appointed under PM Package was issued: and

Whereas, no objection/representation against the said tentative seniority list has been received from the concerned official within the prescribed time and accordingly, the final seniority list was issued by this office vide this office order dated: 27-06-2022; and

Whereas, no Driver has been appointed other than PM Package as on date and in compliance to DMRRR Government Order No. 34-JK(DMRRR) of 2022 dated: 22-06-2022 based on Administrative Council Decision No. 89/6/2022 dated: 08.06.2022, Four (04) number of Drivers, appointed under PM Package vide Government Order No. REV/MR/206 of 2010 dated: 27-12-2010, Order No. PS/81-RRCM of 2018 dated: 02.04.2018 & Order No. 78-RRCM of 2018 dated: 30.05.2018 as given below:

Whereas, vide this office No. RRCM/Estt/22-23/741 dated: 29.06.2022, these Drivers were asked to submit their APRs, Work and Conduct and Integrity Certificates; and

Whereas, Sh. Joginder Singh, Driver fulfils his eligibility (Qualifying service more than 05 years) and has submitted his APRs, work and conduct and integrity certificates; and

Whereas, as per the rule for promotion of Driver-II to Driver-I (i.e, Qualifying service more than 05 years), so that only one (01) Driver out of 04 Drivers mentioned above has been considered for placement to the next higher level as per the eligibility (Qualifying service):-

Whereas, Vigilance clearance of above mentioned Driver has not been received yet in the department. However, in case any adverse report is received from GAD/ACB, the elevation order in that case shall be presumed withdrawn ab-initio.

Therefore, as approved by the Administrative Department (Department of Disaster Management, Relief, Rehabilitation & Reconstruction) the Driver appointed under PM Package on the Supernumerary posts is hereby placed as I/C Driver Grade-I on the Supernumerary posts created by the Department of DMRRR vide Government order No-34-JK-(DMRRR) of 2022 dated 22-06-2022 in his own Pay and Grade with charge allowance admissible under rules and his confirmation shall be made by the Departmental Promotion Committee, Subject to outcome of writ petition(s) if any pending before any Hon'ble Court of Law
