ORDER

Whereas, 208 units of accommodation at Transit Camp, Vessu District Kulgam are at advanced stages of completion.

Whereas, this office has maintained date wise list of PM Package Employees appointed in District Anantnag/Kulgam.

Whereas, a number of employees have been allotted independent accommodation at Transit Camp Vessu District Kulgam.

Whereas, in order to allay apprehension of employees recruited under PM Package who have not been allotted any Government Accommodation at any Transit Camp in Kashmir Valley, it has been felt that the accommodation under completion requires to be allotted as per norms/guidelines framed by the Government.

Whereas, Government Order No. 29-DMRRR of 2018 dated 09.05.2018 has a detailed criteria for allotment of accommodation laying special emphasis on the year of Joining of Service in Valley for PM Package Employees.

As such, Annexure 'A' to this order contains the names of PM Package Employees, posted in the twin district of Kulgam and Anantnag in whose name formal allocation of accommodation at Transit Camp Vessu, District Kulgam is made in anticipation of formal completion to be done by Executing Agency (i.e. JKPCC).

The criterion as laid down in Govt Order mentioned supra is as:-

- 1. Allotment shall be made in respect of PM Package Employees as per their date of Joining Service in Valley.
- 2. Specially abled PM Package Employees residing in respective transit camp on sharing basis or outside camp.
- 3. Couple (Husband and Wife both appointed under PM package) and residing on sharing basis in transit camp or living outside camp.
- 4. Female PM Package Employees residing on sharing basis in transit camp or living outside camp.
- 5. Male PM Package Employees residing on sharing basis in transit camp or living outside camp.
- 6. Any PM Package Employee having terminal illness or his/her immediate spouse.

It is further ordered that any PM Package employee or any individual occupying the aecommodation in violation of Government Order No. 29-DMRRR of 2018 Dated

21-01-2021.

09.05.2018 is hereby termed as illegal and unauthorized occupant and is accordingly directed to evict immediately, failing which legal recourse of action shall be adopted.

In addition to above the allotment of accommodations is made with the following conditions:-

- a. The accommodation is the property of Department of DMRRR and is allotted to the PM Package employee purely in his/her capacity as such employee.
- b. The allottee shall have no right to lease, rent, mortgage, sell or transfer the accommodation and the same shall always be the property of the Department of DMRRR.
- c. The property shall revert back to the Department of DMRRR as and when the employee leaves the job, retires or is not in job for any reason whatsoever.
- d. The allottee shall be responsible for any damage caused to the Government property during his/her occupation.
- e. The allotte shall handover the keys of the said accommodation to the concerned authority as and when he/she retires on supernnuation or on leaving the job.
- f. The accommodations are purely meant for PM Package employees and any employee other than PM Package employee does not have any legal right to occupy the said accommodation.
- g. The allottees shall move to the allotted accommodation as and when the same is complete in all respects.
- h. This allotment is subject to the condition that the date of joining of service in District Anantnag/Kulgam as given by the Employee is factually correct. The department shall have the authority to cancel such accommodation if the date of joining is found incorrect.
- i. The department shall be at liberty to cancel the accommodation, if at any point of time it is found that the allottee is in possession of any other Government accommodation in any of the transit camps across the Kashmir Valley.

i. The allottee shall follow the instructions/directions to be issued by the 21-01-2021.
