Subject: Allotment of Accommodation.

ORDER

Whereas, Quarter No. K-3 at Migrant Camp Nagrota (TRT) was allotted to Smt. Kamla Devi Wd/o Late Sh. Prakash Singh who was registered as migrant for single soul and has expired in the year 2011;

Whereas, on verification it revealed that her daughter in law namely Smt. Poley Devi W/o Pritam Singh had illegally occupied the said Quarter;

Whereas, on verification it was revealed that Smt. Poley Devi W/o Pritam Singh, her family already owns a house at Dhoke Waziran Nagrota;

Whereas, the sole aim of providing Government Accommodation to the migrants is that they are provided with a shelter to live a dignified life with social security as they have left their homes and places of their original residence;

Whereas, in the instant case a migrant to whom the Government accommodation was allotted and was a single soul is no more and her allotted quarter was illegally occupied by her daughter in law namely Smt. Poley Devi W/o Pritam Singh as her family already owns a house at Dhoke Waziran Nagrota;

Whereas, the premises is a Government Property and the ownership of which still lies with the Government as at no point of time the allottee was granted ownership of the premises and it is the prerogative of the Government to put the Government Property to judicious use;

Keeping in view the above facts the allotment of Qtr No. K-3 at Migrant Camp Nagrota (TRT) issued in favour of Smt. Kamla Devi Wd/o Late Sh. Prakash Singh is hereby cancelled with immediate effect and the same quarter i.e, K-3 at Migrant Camp Nagrota (TRT) is allotted to Smt Varsha Raina Divorcee Kashmiri Migrant registered with Migrant Zone Muthi bearing, D.Form No. 0042267, Data Form No. 42290 under Relief Category for 02 souls (Self, and Son).

The allotment is made on purely merit basis with an aim to provide succor and relief to a needy migrant family which is purely sustaining on monthly cash assistance of Rs.6500/- and free ration (Rice=18 Kgs, Atta=04 Kgs & Sugar 01 Kg) per month and can't with stand the financial burden of ailments and other constraints.

Camp commandant Nagrota to ensure that the Qtr No. K-3 is got vacated in presence of the Police Party with due record of the proceedings and the new allottee i.e, Smt Varsha Raina Divorcee is handed over the possession the said quarter with immediate effect.
