Subject: Allotment of Accommodation.

**ORDER**

Whereas, Quarter No. E-6 at Migrant Camp Nagrota (TRT) was allotted to Sh. Pran Nath Pandita S/o Thakur Dass who stands registered with the Relief Organisation under Government Employee Category with Zone TRT Nagrota bearing D.Form No. 019899, Data Form No. 13541;

Whereas, on verification it revealed that Sh. Pran Nath Pandita owns his own house at Muthi and is not residing in Qtr. No. E-6 and is presently residing in his own house at Muthi Jammu;

Whereas, Sh. Pran Nath Pandita was not residing in the said quarter and the same was locked since last 08 years which has been reported by the Camp Commandant Nagrota vide No. CC/Nag/22-23/1251 dated: 03.02.2023;

Whereas, several notices for eviction of the Quarter were duly issued by Camp Commandant Nagrota vide No. CC/Nag/2023-24/Camp dated: 03.08.2022; No: CC/Nag/2021-22/Camp dated: 15.11.2022 which were also pasted on the Main Door of the Quarter No. E-6 with directions to the allottee to vacate the premises;

Whereas, Sh. Pran Nath Pandita didn't respond to the opportunity of being heard provided to him;

Whereas, the sole aim of providing Government Accommodation to the migrants is that they are provided with a shelter to live a dignified life with social security as they have left their homes and places of their original residence;

Whereas, in the instant case a migrant who is a Government Employee has constructed his own house and is socially well off and does not require any such assistance from the Government;

Whereas, the premises is a Government Property and the ownership of which still lies with the Government as at no point of time the allottee was granted ownership of the premises and it is the prerogative of the Government to put the Government Property to judicial use;

Keeping in view the above facts the allotment of Qtr No. E-6 at Migrant Camp Nagrota (TRT) issued in favour of Sh. Pran Nath Pandita S/o Sh. Thakur Dass is hereby cancelled with immediate effect and the same quarter i.e, E-6 at Migrant Camp Nagrota (TRT) is allotted to Smt. Santosh Devi Wd/o Late Sh Kamal Singh Kashmiri Migrants registered with Migrant Zone Nagrota bearing Ration Card No. 431, D.Form No. 058447, Data Form No. 36092 under Relief Category for 03 souls (Self, Daughter and Son) who is still residing in ORT at Nagrota, the erstwhile camp which was dismantled by the Government and Camp Nagrota with Two Room Tenements (TRT) was established and for some reasons her case was never considered for allotment. More so the present place where she was residing is secluded and she was under constant threat from anti-social elements, being a lone lady with grown up daughter. The allotment is made on purely merit basis with an aim to provide succor and relief to a needy widow migrant lady and her family who is purely sustaining on monthly cash assistance of Rs.9750/- and free ration (Rice=27 Kgs, Atta=06 Kgs & Sugar 01 Kg) per month.

Camp commandant Nagrota to ensure that the Qtr No. E-6 is got vacated in presence of the Police Party with due record of the proceedings and the new allottee i.e, Smt. Santosh Devi Wd/o Sh. Kamal Singh is handed over the possession the said quarter with immediate effect.
