**Subject: Allotment of accommodation to PM Package Employees at Wandhama, Ganderbal.**

**Order No: 06-RRCM of 2023**

**Dated: 24.06.2023**

Whereas, 64 quarters were inaugurated by the Hon'ble Lieutenant Governor, UT of J&K for the employees appointed under Hon'ble PM's Package in the month of April 2023, and;

whereas, in terms of order issued under endorsement no. RRCM/Sgr/23-24/207-12 dated 06.06.2023, a provisional list of PM package employees/prospective allottees was made public and objections were sought as to any entry or other detail in the said list, and;

whereas, several objections were received from different quarters in respect of 10 PM Package employees figuring in the aforementioned list. The Objections were considered on merit and disposed of. The details are given here under:

Whereas, upon consideration of the objections and other records, 08 PM's Package employees/ prospective allottees figuring in the provisional list have been expunged from the instant allotment order and in their place 08 Hon'ble PM package employees have been included as per their entitlement in terms of the criteria laid down vide Govt. order no. 05-JK(DMRRR) of 2023 dated 19.01.2023.

Whereas, Monika Dhar & Sandesh Thathoo figuring at S.No. 04 under Couple Category of the year 2017 in the provisional list have through the medium of an application voluntarily relinquished their right for allotment of accommodation at Wandhama, Ganderbal as such to their name is expunged from the instant allotment list.

Now, therefore, the final allotment list forming **Annexure-A** to this order is hereby issued in favour of the eligible Hon'ble P.M Package employees/allottees. The allotment shall be subject to the following terms & conditions:-

1. The accommodation is the property of Government and is allotted to the PM Package employee purely in his/her capacity of being such employee.
2. The allottee shall be personally responsible for any type of damage caused to the Government property during his occupation and shall personally upkeep/maintain the property.
3. The allottee shall not sublet, mortgage, sell or transfer the accommodation in any manner whatsoever.
4. The allottee shall not make any concrete structural changes within the premises, except with the permission of the Competent Authority.



5. The allottee shall enter into agreement with the Jal Shakti and KPDCL to the effect that he/she will bear the necessary usage charges on his/her own.
6. The eligible PM Package employees shall be entitled for allotment of accommodation at one location only. In case it transpires that the allottee or his/her spouse has availed accommodation at more than one location, the allotments shall be cancelled ab-intio, besides, such allottees shall be black listed/debarred from availing any accommodation in future.
7. The allotment is subject to the condition that the date of joining of services as given by the employee is factually correct. If at any stage, it comes to the notice, that the allottee had concealed any facts with regard to his/her appointment/joining, the allotment shall be liable to be cancelled without any notice.
8. The allottee shall follow the instructions/directions to be issued by the Government from time to time.
