Subject: Allotment of Accommodation.

**ORDER**

Whereas, Quarter No. A-6 at Migrant Camp Nagrota (TRT) was allotted to Smt. Meenawati Wd/o Late Sh Radha Krishan who was registered as migrant for single soul and has expired in October in 2020;

Whereas, on verification it revealed that her servant namely Dalip R/o Kishtwar who is a non-migrant had illegally occupied the said Quarter;

Whereas, the sole aim of providing Government Accommodation to the migrants is that they are provided with a shelter to live a dignified life with social security as they have left their homes and places of their original residence;

Whereas, in the instant case a migrant to whom the Government accommodation was allotted and was a single soul is no more and her allotted quarter was illegally occupied by her servant namely Dalip resident of Kishtwar who is a non migrant;

Whereas, the premises is a Government Property and the ownership of which still lies with the Government as at no point of time the allottee was granted ownership of the premises and it is the prerogative of the Government to put the Government Property to judicious use;

Keeping in view the above facts the allotment of Qtr No. A-6 at Migrant Camp Nagrota (TRT) issued in favour of Late Smt. Meenawati Wd/o Late Sh. Radha Krishan is hereby cancelled with immediate effect as she is no more and the same quarter i.e, A-6 at Migrant Camp Nagrota (TRT) is allotted to Sh. Shanker Dass S/o Nihaloo Ram Kashmiri Migrant registered with Migrant Zone Bari Brahmana bearing, D.Form No. 015912, Data Form No. 20100 under Relief Category for 03 souls (Self, wife & Daughter).

The allotment is made on purely merit basis with an aim to provide succor and relief to a needy migrant family which is purely sustaining on monthly cash assistance of Rs.9750/- and free ration (Rice=27 Kgs, Atta=06 Kgs & Sugar 01 Kg) per month and cannot with stand the financial burden of ailments and other constraints.

Camp commandant Nagrota to ensure that the Qtr No. A-6 is got vacated in presence of the Police Party with due record of the proceedings and the new allottee i.e, Sh. Shanker Dass S/o Nihaloo Ram is handed over the possession the said quarter with immediate effect.
