For facilitation of Kashmiri Migrants with an aim to ensure enrolment of eligible Kashmiri Migrant Voters in the Electoral Rolls of their original Constituencies of residence, an awareness cum enrolment campaign has been envisaged w.e.f. 10.04.2023 to 20.04.2023 titled: **Zonal Area Awareness Campaign-ZAAC-SSR-2023 under SVEEP.**

- I. For the purpose of ZAAC-SSR-2023 each official of the Zone is designated as Booth Level Officer(BLO).

Each official/BLO shall carry the Election Kit with all the necessary pre-requisites like Forms, notification of Constituencies etc. so that households are clear with their respective areas of Constituencies to which they belong.

The similar shall be followed by Camp Commandants in their camps. The Camp Commandant shall ensure that one BLO visits one block per day and shall submit as per the Performa as mentioned above' on daily basis.

Ms. Reetika Arora (JKAS) AC(R) Mob.:9419222404 is overall Nodal Officer for ZAAC-SSR 2023 and she shall apprise Relief and Rehabilitation Commissioner(M) about the daily progress area wise. She will also maintain liaison between Zone and the AERO(M) for the necessary.
