Notification

Jammu, the 13<sup>th</sup> August, 2024

S.O. **392** .-In exercise of the powers conferred by sub-section(1) of section 40 of the National Food Security Act, 2013, the Government of Jammu and Kashmir hereby directs that in sub-rule (2) of rule 3 of the Jammu and Kashmir Food Security Rules, 2021, the following shall be added as first and second proviso; namely:-

"Provided that such inclusion and exclusion in respect of Kashmiri/Jammu Migrants shall be established by the Relief & Rehabilitation Commissioner (M) on the recommendations of the Committee comprising of the following members:-

1.	Relief & Rehabilitation Commissioner (M)	Chairman
2.	Deputy Commissioner (Relief)	Member
3.	Assistant Commissioner (Relief)	Member
4.	Tehsildar (T)/Zonal Officer Concerned	Member
5.	Tehsil Social Welfare Officer	Member
6.	Tehsil Supply Officer	Member

Provided further that the Relief Assistance in respect of Kashmiri/Jammu Migrants shall not be counted as Income, but as a source of sustenance only, as decided by the Department of Disaster Management, Relief, Rehabilitation & Reconstruction, Jammu and Kashmir."
